JANUARY PREVIEW

Our east end of Baltimore County has seen some major development lately and it is only going to get more problematic. When you hear of land preservation in the County, you think of rural northern acreage, not around here. Well stay tuned! Our January speaker will be Megan Benjamin, Land Preservation Coordinator for the Baltimore County Department of Planning. She heads up the Coastal Rural Legacy Area (CRLA) program, which covers almost 15,000 acres adjacent to the county shoreline between the Gunpowder River and North Point, including many of our rivers and creeks in Bowleys Quarters. Over \$2 million in grant funds were recently awarded to this program in the fall, and Megan will bring us up to date on how these funds will be directed to protect and enhance our coastal areas. DECEMBER MEETING HIGHLIGHTS

The meeting was abbreviated so that the Holiday Giving Party could take place. The following information was reported.

- The Treasurer's report and November minutes were read and approved.
- The BQIA Hall AED's are in place and AED training is being planned to be held in January.
- BQIA is continuing talks with Forsite regarding the Crane site development. Our President and Board representatives have been meeting with La Farge developers as well. As with any possible development, BQIA desires to keep lines of communication open to maintain a "seat at the table" as plans move forward. Along these lines, a Cordish Committee has been established to address growing concerns with the maintenance and occupancy of the Carroll Island Shopping Center.
- The Back River Water Treatment Facility is still not in compliance with regard to discharge but there has been some measured progress.
